# HOW DO NEW STUDENTS GET STARTED At NorthWest Arkansas Community College

- 1. Apply Online. NWACC Online Application. There is a \$10 application fee that can be paid online at the time the application is completed. Depending on how long it takes for your transcripts to arrive, there could be 2-3 day waiting period before you receive a PIN number allowing you to enroll in courses. The cost per hour for out of state tuition is \$208.75.
- 2. Complete the placement tests to determine which level of Math, English and Reading classes you will begin with <u>Information on Compass Test</u>. Contact the NWACC testing center and personnel will assist you in finding a location in your area to take the test. Cost is generally about \$10. Transfer students who have already completed college level Mathematics or English are exempt.
- 3. Request an Official Transcript from your high school and from any colleges where you have taken classes be sent to the NWACC Admissions Office. Your high school transcript MUST include your graduation date. Your Official Transcript must arrive at the NWACC Admissions office (mailed or hand delivered) in a SEALED envelope. Transcripts will not be evaluated until all transcripts have been received. UT Arlington students must show successful completion of CSHO certification from UT Arlington and a copy of their active OSHA Trainer card.
- 4. Pay your Tuition. Please check the online academic calendar for tuition dates and deadlines. Tuition can be paid either online, over the phone (479-619-4291 or 1-800-995-6922 ext. 4291) or in person at the cashier's office on the second floor in the student center at NWACC. Since you are probably away from campus, it is highly suggested you pay online.
- 5. Buy your books. You should purchase your books prior to the first day of class. **NWACC Bookstore**
